Rule 2A. INDEPENDENCE

- (1) The Community shall always remain self-governing independent and autonomous and shall be governed according to this paramount clause, and the other clauses of the Constitution. At no time and under no circumstances shall the Community relinquish any of its rights or be bound by terms or clauses foreign to this Constitution. Neither in its government nor in its administration shall the Community be subject to any ecclesiastical, political, or other, body or authority.”
- (2) In order to make known the history of the Community and in particular the attempts to deprive it of its independence and democratic government the Community shall finance, undertake and maintain the compiling, editing, printing, distribution and publication of such history under the auspices of the Membership Committee.

Rule 4A. FUNDAMENTAL RULES CONTROLLING APPLICATIONS

In Controlling applications the Membership Committee must absolutely satisfy itself that the applicant is a bona fide fervent supporter of the Community and of the Community as an institution as is set forth in this constitution, the reason for this being the differences and divisions amongst Greeks in Australia on matters of independence and autonomy of the Community as well as on ecclesiastical jurisdiction, and it bearing in mind always the absolute autonomy of the Community and its not being bound to any ecclesiastical authority thus undermining its independence.

Rule 6. EXPULSION OF MEMBERS

If a member of the Association is reported to have proselytised a view point contrary to Rules 2a and 4A and/or whose conduct challenges or undermines the autonomy or standing of the Community shall, in the opinion of the Council, be guilty of conduct contrary to the interests and objects of the Association. The member shall be called upon by registered letter addressed to the member at the member’s latest recorded address to appear before a meeting of the Administrative Council and there to show cause why the member should not be expelled and if the member fails without reasonable excuse conveyed to the Council to attend or if in the opinion of the Council at such meeting the member fails to show cause the member shall be suspended.

Provided that when a member shall have been so suspended the matter shall be put before the next General meeting and shall clearly be shown on the agenda thereof as received by the members and shall include the name of the suspended member. The member may at such meeting be expelled from membership of the Community or the General Meeting may annul the member’s suspension. Provided that the member under suspension will be advised by registered letter posted at least ten days prior to the General Meeting to be present thereat.

In addition at least thirty financial members of the Community may move for the expulsion of a member of the Community and this motion shall be examined at a General Meeting and if the General Meeting is satisfied that the behaviour of the member is contrary to the interests and objects of the Community it may in its absolute discretion expel such member.

Provided that such member shall have been forwarded a registered letter by the Secretary of the Community at least ten days prior to the General Meeting stating the nature of the proposed motion and that the member has the right to be present thereat and provided the nature of the motion is clearly shown on the agenda received by the members and stating the name of the member whose expulsion is sought to be moved. In determining whether a member is guilty of conduct contrary to the interests and objects of the Community particular regard must be had to the provisions of clause 4A hereof.
